Water Distribution Agreement

Emirates Water Factory with its place of business at P.O. Box 1520, Dubai, United Arab Emirates (herein after referred to as '**Supplier**')

Pace International School LLC with its place of business at Sharjah, UAE (herein after referred to as the '**Customer**').

Article 1: General

- 1.1 The Supplier will supply the Customer **Pace International School LLC** in **5 gallon bottles** at the agreed quality and price for a period mentioned in Article 4.1 from the date this price agreement is made, and continue thereafter till the agreement is terminated by either party in writing.

Article 2: Prices & Terms of Payment

- 2.1 The price per bottle of 5 gallon water will be:

S. No	Description	Price
1	1 bottle x 5 gallon water	AED 3.25
2	36 cups x 200 ml in one carton	AED 5.50

- 2.2 **5% VAT** will be applied.
- 2.3 The Customer shall arrange payment after **30 days** from the date of Invoice.
- 2.4 The Supplier will provide the required number of water bottles free of cost on a returnable basis to the Customer and ensures the maintenance throughout the contract period. (Terms and Conditions applied)
- 2.5 In case of damage or loss of bottles caused by the Customer other than the normal wear and tear, the Customer agrees to pay AED 16.00 per bottle to the Supplier.

Article 3: Terms of Delivery

- 3.1 The Supplier agrees to provide the delivery to a single point (either in the 2nd party's warehouse or an assigned storage space wherever in the Emirate of Sharjah as assigned on the mutual agreement)

Article 4: Agreement Duration

- 4.1 This agreement is valid for a period of **1 year** starting **1st January 2026 to 31st December 2026**.
- 4.2 This agreement supersedes and cancels all previous agreement, if any.
- 4.3 A new agreement or amendment to this agreement shall be drafted, approved and signed by both parties for any changes necessary in future.

Article 5: Termination Clause

Either side must give 2 months' notice to terminate supply of water in case of good reason.

Article 6: Force Majeure

Neither party will be liable to the other for any failure or delay in performance of their obligations under this diligence the said party could not have prevented or overcome their obligations to supply / order in event of war, strikes, riot or act of God and by any other major unpredicted technical constraints which prevent the production or supply.

Article 7: Governing Law

This Agreement shall be governed by and interpreted in accordance with the laws of the United Arab Emirates.

Any and all dispute would be between the parties from the interpretation of this Agreement or for any other reason, Shall be amicably resolved, however in case of failure; such dispute shall be referred to the courts of **Dubai** to settle this matter.
